### Training to meet your needs

This course is designed for suppliers of goods, services and works to the UK public sector, and is focused on what suppliers need to know about the new Procurement Act, which comes into force in February 2025.

The new Procurement Act will have a significant impact on suppliers across a broad range of areas; including debarment & exclusion, the new Centralized Digital Platform, contract performance, additional notices and the novel competitive flexible procedure. This training covers all these - must know - areas for suppliers, and more. It aims to provide a foundation of the key concepts, terms, processes and activities that suppliers will face when bidding for public sector work under the new Act. The training is delivered by experts who have a strong background in public sector contracting and whole life commercial contract management.

### Course outline

The course explains the overarching thinking and objectives of the Procurement Act, and how this impacts suppliers. It walks through the different procurement approaches that buyers can use, as well as what needs to happen at every step of the procurement cycle. The event will also help to demystify common procurement terminology and provide guidance on responding to invitations to tender ("ITTs").
