This Notice contains important information about how (and why) we gather and process information about you when you visit our website. Control of your data

What information do we collect?

We use different methods to collect data from you and about you including through:

Direct interactions. You may give us your identity contact and financial data by filling in forms or by corresponding with us. This includes personal data you provide when you: apply for our services; subscribe to our services; request marketing information be sent to you; participate in a survey or give us some feedback;

Automated technologies or interactions. As you interact with our website we may automatically collect technical data about your equipment, browsing actions and patterns. We collect this personal data by using cookies and other similar technologies.

Third parties or publicly available sources. We may receive personal data about you from various third parties and public sources, namely: analytics providers, such as Google; and identity and contact data from publicly available sources such as Companies House.

We may collect, use, store and transfer different kinds of personal data about you as indicated below:

Identity data to include: first name; maiden name; last name; username or similar identifier; marital status; title; date of birth and gender;

Contact data, including email address and telephone numbers;

Transaction data about services you have purchased from us;

Technical data, including: internet protocol (IP) address; your login data; browser type and version; time zone setting and location; browser plug-in types and versions; operating system and platform and other technology on the devices you use to access our website;

Profile data, including: your username and password; services purchased; your interests; preferences; feedback and survey responses;

Usage data, including information about how you use our website and services purchased;

Marketing and communications data, including: your preferences in receiving marketing from us and your communication preferences.

Where appropriate, we voice record customer interactions, therefore any information captured via this media will automatically be stored for training and monitoring purposes.

Third parties or publicly available sources.

We may receive personal data about you from various third parties and public sources as set out below:

Technical Data from analytics providers or search information providers, such as Google and

Identity, Contact, Professional, Financial or Welfare Data from our clients or other third parties if you are involved in or otherwise concerned with one of their matters or publicly available sources such as Companies House or Electoral Register.

External Third Parties means:

Service providers acting as processors who provide IT, online data room hosting and website and system administration services.

Suppliers based in the UK providing marketing services to us, or with whom we are conducting joint marketing exercises.

Professional advisors acting as processors including lawyers, bankers, auditors and insurers who provide consultancy, banking, legal, insurance, pension and accounting services.

Our professional indemnity insurers or brokers, and our auditors, or risk managers who we or they may appoint.

How we use your information

Data protection law states that we can only use your personal data if we have a lawful basis for doing so, and that we must tell you what it is. Sharing and transferring your personal data

We will only share your data with others if it is necessary to:

Do so for legitimate business purposes; and/or

Comply with a legal or regulatory obligation; and

We are satisfied that appropriate measures can be taken to protect your personal data and restrict the purpose for which it is used.

Overseas Transfers

None of the information that we collect, process or store as a result of this website is transferred outside of the European Economic Area (EEA). This includes information that we exchange with any third-party organisation as described above.

How long will we keep your personal data?

We will keep your personal information for as long as we need it to fulfil the purpose for which it was collected, including for the purposes of satisfying any legal, accounting or reporting requirements.

Keeping your personal information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used, or accessed in an unauthorised way. Those processing your information will only do so in an authorised manner and are subject to a duty of confidentiality.

We have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulatory or the suspected data security breach where we are legally required to do so.

Your rights

In certain circumstances you have rights under Data Protection Law in relation to your personal data which you can exercise free of charge, namely the right to:

Request access to your data;

Request correction of your data;

Object to the processing of your data;

Request that the processing of your personal data be restricted;

Request transfer of your personal data;

Withdraw any consent that you may have given to the processing of your data.

We may need to ask for information to confirm your identity, to ensure that personal data is not disclosed to a person who is not entitled to receive it, before we can process your request.
